

## WOOL MARKET REPORT – 2 April 2025

On the 26<sup>th</sup> wool auction of the 2024/2025 sale season, the average clean wool market indicators for good quality long fleece wool (MF4/MF5) with a tenstle strength of 35 (NKT) were as follows:
