Die verbod op uitvoer van wol na China wat April 2022 deur China geïmplementeer is, is nog steeds van toepassing op die Suid Afrikaanse skeersel.

Wolveilings het gedurende die vorige seisoen steeds voortgegaan ten spyte van groot volumes wol wat nie uitgevoer kon word nie.

Hierdie volumes wol wat tans as voorraad gedra word, asook die groot onsekerheid rakende die opheffing van die verbod, plaas groot druk op die bedryf.

Om koopkrag op die komende veilings te versterk is 'n besluit geneem om uitstel van betaling aan die kopers te gee tot 10 werksdae na die veiling, dit impliseer dat produsente 10 werksdae na die veiling uitbetaal sal word.

The ban on exports of wool to China implemented by China in April 2022 still applies to the South African clip.

Wool auctions continued during the previous season despite large volumes of wool that could not be exported.

These volumes of wool currently carried as stock, as well as the great uncertainty regarding the lifting of the ban, put great pressure on the industry.

To strengthen purchasing power at the upcoming auctions, a decision was made to give deferral of payment to the buyers up to 10 business days after the auction, this implies that producers will be paid out 10 business days after the auction.
